


Each month, the city collects a one-percent gross receipts tax from all businesses in Pigeon Forge. This is then tracked and reported by sector. As a destination, Pigeon Forge is not overly dependent on any single business sector because of the strong product mix. This is one of the reasons why the city is so successful. If a category trends downward over a period of time, reasons are identified and strategies are evaluated and implemented to help reverse negative trends.
